<b>Section 1: Unaccompanied Homeless Youth</b>

Unaccompanied homeless youth are described as young people (under the age of 21) who lack safe, stable housing and are not now under the care of a parent or guardian. These youth may have run away from home or been forced to leave by their parents. They may live in a variety of temporary situations, including shelters, the homes of friends or relatives, cars, campgrounds, public parks, abandoned buildings, motels and bus or train stations.

Northpoint Bible College requires documentation stating that after July 1, 2018, the unaccompanied homeless youth was living in a homeless situation, as defined by Section 725 of the McKinney-Vento Act, and was not in physical custody of a parent or guardian.

To be considered as an unaccompanied youth who is homeless, the student must have this form signed by one of the following entities:

## Section 2: Unaccompanied Youth at Risk of Being Homeless

This section is for unaccompanied youth (under the age of 21) providing their own living expenses and who are at risk of being homeless.
